I was trying to solve this stochastic differential equation with  $X_0 = x_0$ ;  $dX_t = a(X_t) dt + \sigma dW_t \iff X_t = x_0 e^{\frac{a}{\sigma^2} t}$  in  $\mathbb{R}$ . Let  $S(a) = \begin{pmatrix} 0 & 1 \\ -a & 0 \end{pmatrix}$ . With the following initial condition, I get the solution  $X_t = x_0 e^{\frac{a}{\sigma^2} t}$  but why? My first thought was that I have to use the Itô process  $dW_t = dW_t + dt$ , but I don't see the connection here...
